- List of all property owners within 150 feet of the property where you wish to install the used dwelling. The list must include the name and mailing address of the property owner and the parcel number. The list must be from the most recent tax roll.
- Signed and notarized affidavit attesting to completeness and accuracy of list of surrounding property owners

Your application must be received by the deadline or it cannot be heard until the following meeting date.

This application and all associated permit applications will be the subject of a Public Hearing before the Okeechobee County Planning Board. It is the responsibility of the applicant to pay for the required advertisement of the public hearing in an Okeechobee newspaper. The advertisement will be prepared by the Planning and Development Department and submitted to the newspaper. The newspaper will then contact the applicant’s contact person for payment of the legal advertisement.
