Variances, Appeals and Installations of Used Dwelling Units**

The Okeechobee County Planning Board/Board of Adjustments and Appeals meets on the fourth Tuesday of each month at 6:00 p.m. at the Okeechobee County Health Department Auditorium, 1728 NW 9<sup>th</sup> Avenue, Okeechobee, Florida. A combined November/December meeting is held on the second Tuesday of December. If all items cannot be heard at the scheduled Tuesday public hearing because of time constraints, the hearing will be continued to Wednesday.

A completed application, supporting documents and appropriate filing fee must be submitted by the deadline date to be scheduled for the indicated hearing date. Incomplete applications will not be scheduled until they are complete. Submit completed application to the Community Development Department, 1700 9<sup>th</sup> NW Avenue, Suite A, Okeechobee, Florida, 34972. The Department suggests that the applicant or a representative attend each hearing.
