Please contact the Community Development Department with any questions regarding building permit applications, requirements for building permits, or regulations addressing the licensing or certification of contractors.
21. Please also be advised that an occupational license or a transient merchant permit may be required.
22. Additional permits or approvals from other regional, state or federal regulatory agencies may also be required.
